Dear Property Owner,

An inspection was made on April 11, 2018, concerning the property located at 607 E. Broad Street (Forney Original Block 40, Lot 1-1). The inspection report notes that the structure located at the above listed address is unsafe and represents a threat to public health, safety, and welfare. The foundation is sinking into the ground and the main structure and roofline are in poor condition.

Chapter 3 of the City of Forney Code of Ordinances states that the minimum standards for continued use and occupancy of all buildings shall be those standards established by the International Building Code. The existence of a public nuisance is a violation that must be remedied by structure repair or removal.

The City of Forney Building Standards Commission will hold a meeting with a public hearing on Wednesday, May 23, 2018, at 6:00 p.m. to discuss this property. The meeting will take place at Forney City Hall, 101 E. Main Street, Forney, TX 75126. The owner, lienholder or mortgagee of the property will be required to submit proof of the scope of any work that may be required to comply with the Code of Ordinances and the time it will take to reasonably perform the work.

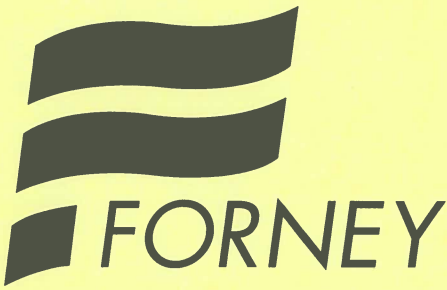
