I. CALL TO ORDER

Mayor Wilson called the meeting to order at 9:07 a.m. Present were Mayor Rick Wilson, Mayor Pro Tem Mary Penn and Council Members Cory McGee, Shaun Myers, Robbie Powers, Kevin Moon and David Johnson. Also present was Interim City Manager Wendle Medford and City Attorney Jon Thatcher.

Mayor Wilson announced that Council would now adjourn into Executive Session under the Texas Government Code, Section 551.074 and called for a motion. Mayor Pro Tem Penn made a motion to go into Executive Session at 9:09 a.m. and Council Member Myers seconded the motion. The motion passed unanimously by a vote of 7 ayes and 0 nays.

II. HOLD EXECUTIVE SESSION UNDER SECTION 551.074 OF THE TEXAS GOVERNMENT CODE TO DISCUSS:

1. Personnel issues including executive search for a city manager.

At 2:25 p.m. Mayor Wilson called for a motion to adjourn out of Executive Session. Council Member Moon made a motion to adjourn out of Executive Session at that time and Council Member Johnson seconded the motion. The motion passed unanimously by a vote of 7 ayes and 0 nays.

At 3:45 p.m. Mayor Wilson called for a motion to adjourn into Executive Session. Council Member Johnson made a motion to adjourn into Executive Session at that time and Mayor Pro Tem Penn seconded the motion. The motion passed unanimously by a vote of 7 ayes and 0 nays.

At 6:45 p.m. Mayor Wilson adjourned the Executive Session. There being no further business to come before the Council, Mayor Wilson adjourned the meeting at 6:45 p.m.
