



**PROPOSAL FOR SALE OF LEASED EQUIPMENT

We are pleased to present this proposal to **City of Forney** ("Buyer") for the sale of the equipment listed on the attached Exhibit "A" (the "Sale Units"), currently leased by Buyer from CSI Leasing, Inc. or CSI Leasing Canada Ltd. (the applicable Lessor referred to herein as "Seller") under Equipment Schedule **002** to Master Lease Agreement No. **300559** (the "Lease").

**Total Sales Price : \$83,441.00** plus applicable taxes.

**Payment Due Date: 04/08/2019**

Buyer's rental obligations for the Sale Units will terminate on **03/31/2019** (the "Termination Date") provided Buyer pays the Total Sale Price by the Payment Due Date. If Buyer does not pay the Total Sales Price by the Payment Due Date, the Termination Date will be the last day of the month in which the payment is received by Seller. If this sale covers only part of the equipment on the Lease, the total rental under the Lease will be reduced by the rental amount set forth on the attached Exhibit "A", effective with the payment due immediately following the Termination Date. Buyer's remaining obligations as lessee under the Lease, including indemnification and liability for personal property tax, shall continue until performed in full.

Seller warrants that (i) on payment of the Total Sales Price, Seller will pass to Buyer title to the Sale Units free and clear of all liens, claims, and encumbrances of any kind except those caused or incurred by Buyer, if any; and (ii) Seller has the full right, power and authority to sell the Sale Units. OTHER THAN THE FOREGOING, SELLER MAKES NO REPRESENTATIONS OR WARRANTIES OF ANY KIND, EXPRESS OR IMPLIED, WITH RESPECT TO THE CONDITION, DESIGN OR PERFORMANCE OF THE SALE UNITS, ITS MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE OR WITH RESPECT TO PATENT INFRINGEMENT OR THE LIKE, AND THE SALE UNITS ARE SOLD ON AN "AS IS, WHERE IS" BASIS. THE SELLER HAS NO LIABILITY TO BUYER FOR ANY CLAIM, LOSS OR DAMAGE OF ANY KIND OR NATURE WHATSOEVER ARISING OUT OF OR IN CONNECTION WITH (i) ANY DEFICIENCY OR INADEQUACY OF THE SALE UNITS FOR ANY PURPOSE, WHETHER OR NOT KNOWN OR DISCLOSED TO BUYER, (ii) ANY DEFECT IN THE SALE UNITS, (iii) THE USE OR PERFORMANCE OF THE SALE UNITS, (iv) ANY INTERRUPTION OR LOSS OF SERVICE OR USE OF THE SALE UNITS, OR (v) ANY LOSS OF BUSINESS, OR ANY OTHER INCIDENTAL OR CONSEQUENTIAL LOSS OR DAMAGE, WHETHER OR NOT RESULTING FROM ANY OF THE FOREGOING, INCLUDING, WITHOUT LIMITATION, PATENT INFRINGEMENT ACTIONS.

Any purchase order Buyer issues is merely for its internal recordkeeping purposes and as a means of confirmation of Buyer's acceptance of this proposal, and does not supersede, modify or serve as a counter-offer to the terms and conditions in this proposal.
