

**Minutes
Forney City Council
Tuesday, February 5, 2019
6:30 p.m. Regular Meeting
City Hall, 101 E. Main Street, Forney, Texas 75126**

I. CALL TO ORDER

Mayor Wilson called the meeting to order at 6:30 p.m. Present were Mayor Rick Wilson, Mayor Pro Tem Mary Penn and Council Members Mike Thomas, Shaun Myers, Robbie Powers, Kevin Moon and David Johnson. Also present was City Manager Tony Carson.

II. INVOCATION / PLEDGE OF ALLEGIANCE – COUNCIL MEMBER DAVID JOHNSON

III. PROCLAMATIONS / PRESENTATIONS

1. Presentation from iChoosr - Group Purchasing Texas Power Switch.

Daniel Wilkinson of iChoosr gave a presentation regarding their program to help citizens get lower electric rates. iChoosr would negotiate to get the lower price and the citizen would sign up for one year. Friends and family of the local citizen (whether they live in Forney or not) are also eligible to sign up for this lower electric rate. Coops and municipals cannot participate. City Manager Carson will research this program and bring the information back to the Council.

Mayor Wilson asked if Council wished to pull any items from the Consent Agenda for discussion. Council Member Moon requested that Consent Agenda No. 1 be pulled. Mayor Wilson called for a motion on the remain items (Consent Agenda Items Nos. 2 through 9). Mayor Pro Tem Penn made a motion to approve Consent Agenda Items Nos. 2 through 9 and Council Member Johnson seconded the motion. The motion passed unanimously by a vote of 7 ayes and 0 nays.

106 Council Member Moon asked Police Chief Sherwin if there are any other companies in the city.
107 Sherwin advised that they must have a yard in the city. Sherwin advised that they went out to bid
108 twice and only Busters submitted a bid. When asked about the difference when an apartment
109 complex calls a towing service to remove cars or if you have Busters remove car, Sherwin advised
110 that when the City has a car towed, it is usually from an accident and it is considered a non-consent
111 tow. When an apartment complex requests a tow, it is a private agreement with a third party and the
112 City cannot regulate who they use.

114 There being no further discussion, Mayor Wilson called for a motion on Consent Agenda Item No. 1.
115 Mayor Pro Tem Penn made a motion to approve Consent Agenda Item No. 1 and Council Member
116 Johnson seconded the motion. The motion passed unanimously by a vote of 7 ayes and 0 nays.

118 VII. DISCUSSION / ACTION ITEMS

119 1. Vision 2025 -- Goals and Initiatives

120 City Manager Carson stated that he has met with all departments to discuss timelines and goals as
121 a result of the November 2018 work session and the departments are working on these items.

124 2. Discuss and consider approval of an Ordinance amending the Code of 125 Ordinances, Article 8.08, entitled "Abandoned and Junked Motor 126 Vehicles," and Article 12.04, entitled "Parking," to regulate the parking 127 of commercial vehicles. [Read Ordinance Caption] 128 129

130 Community Development Director Peter Morgan discussed the background of this item. The
131 ordinance provides for the regulation of commercial vehicle parking. Staff has received several
132 complaints about the proliferation of commercial vehicles parked in nonresidential districts. The
133 ordinance proposes restrictions while allowing necessary exceptions for such parking.
134

135 Chief Sherwin stated that he thought that warnings and being shown where they can park should be
136 sufficient for now.
137

138 Mayor Wilson called for a motion. Council Member Johnson made a motion to approve the
139 Ordinance and Council Member Moon seconded the motion. The Ordinance caption was read as
140 follows:

145 AN ORDINANCE OF THE CITY OF FORNEY, TEXAS, AMENDING CHAPTER 12 OF THE CODE OF

147 AND JUNKED MOTOR VEHICLES," BY AMENDING THE DEFINITION OF ABANDONED MOTOR
148 VEHICLE AND BY AMENDING ARTICLE 12.04, "PARKING," BY ADDING SECTION 12.04.007,
149 ENTITLED "COMMERCIAL VEHICLE PARKING IN NON-RESIDENTIAL DISTRICTS"; PROVIDING
150 A PENALTY; REPEALING ALL CONFLICTING ORDINANCES; PROVIDING A SEVERABILITY
151 CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

153 The motion passed unanimously by a vote of 7 ayes and 0 nays.
154

155 3. Discuss and consider approval of an Ordinance amending the FY 2018- 156 19 Budget to transfer \$275,000 from the Utility Fund to the Utility CIP 157 fund for the Weaver Lift Station replacement project. [Read Ordinance 158 Caption] 159

160 Finance Director Deborah Woodham discussed the background of this item. This City Council
161 approved a contract for the replacement of the Weaver Lift Station at the January 8, 2019, meeting.
162 The project was originally budgeted as a maintenance and rehabilitation item for the lift station. It
163 was later changed to a replacement of the lift station thus making it a CIP project. This Ordinance
164 transfers the budgeted funds from the Utility operating fund to the Utility CIP fund.
165

166 Mayor Wilson called for a motion. Council Member Myers made a motion to approve the Ordinance
167 and Council Member Powers seconded the motion. The Ordinance caption was read as follows:

179 The motion passed unanimously by a vote of 7 ayes and 0 nays.

181 **VIII. CITY MANAGER'S REPORT**

183 City Manager Carson had several items:
184

185 1. The roof at City Hall is being repaired. The repairs will also include the windows
186 and some building joist. Construction time will be about 3 weeks.
187

188 2. The North Texas Municipal Water District is changing the disinfectant that they use
189 and that will be between March 1 and April 1.
190

191 3. The National Weather Service will be offering free training at the Kaufman Fire
192 Station.
193

194 Council Member Johnson asked about the painting of the crosswalks – will it include the north side
195 of downtown near the railroad tracks? Carson advised it will be included. Right now, our Public
196 Works guys are working with the equipment to be sure that when they do the painting that it will be
197 perfect.
198

199 Mayor Pro Tem Penn asked about the lighting of the plaques that are around our building. Carson
200 stated he would check into that.
201

202 **IX. COUNCIL COMMENTS**
203

204 Council Member Johnson thanked everyone for coming out. He welcomed Mike to the Council and
205 wished him luck as he takes on another endeavor. He thanked Staff regarding the truck parking
206 solution.
207

208 Mayor Pro Tem Penn welcomed Mike and stated she is excited about Raising Cane's.
209

210 Council Member Moon welcomed Mike and thanked everyone for being here tonight.
211

212 Council Member Powers welcomed Mike.
213

214 Council Member Myers thanked Staff for their hard work and welcomed Mike to the Council.

216 Council Member Thomas thanked the Council for this opportunity to serve the community and stated
217 he looks forward to working with everyone.

218

219 Mayor Wilson stated that the Forney High School cheerleaders did well at Nationals. The grand
220 opening of the Forney Learning Academy was a good event. He welcomed Cane's to the community.
221 God Bless.

223 Mayor Wilson stated that Council would now adjourn into Executive Session and asked for a motion
224 to adjourn into Executive Session under Chapter 551, Texas Government Code, Sections 551.071,
225 551.072, 551.074 and 551.087. Council Member Johnson made a motion to adjourn into Executive
226 Session at 7:37 p.m. and Mayor Pro Tem Penn seconded the motion. The motion passed
227 unanimously by a vote of 7 ayes and 0 nays.

Council returned to Chambers at 9:38 p.m. Mayor Wilson called for a motion to adjourn out of Executive Session at that time. Mayor Pro Tem Penn made a motion to authorize the City Manager to provide notice to the School District to terminate the Master Consolidated Interlocal Agreement between the City of Forney and the Forney Independent School District. Council Member Johnson seconded the motion. The motion passed unanimously by a vote of 7 ayes and 0 nays.

Council Member Thomas made a motion to authorize the City Manager to execute a Separation Agreement and General Release with Wendle Medford. Council Member Myers seconded the motion. The motion passed unanimously by a vote of 7 ayes and 0 nays.

There being no further business to come before the Council, Mayor Wilson adjourned the meeting at 9:40 p.m.
